KNOW all Men by these Presents, That We
Robert Gray, Joseph Hartan & Francis Hickman

Persifer Frazer are held and firmly bound unto
Register for the Probate of Wills,
and granting Letters of Administration, in and for the County of
Chester, in the Commonwealth of Pennsylvania, in the Sum of,
One Hundred & fifty Pounds, to be paid to the said *Persifer*
Frazer his certain Attorney, Executors, Admini-
strators or Assigns: To the which Payment well and truly to be
made, we bind ourselves jointly and severally for and in the whole,
our Heirs, Executors, and Administrators, firmly by these Presents,
Sealed with our Seals. Dated the *Fifteenth* Day of *August*
in the Year of our Lord one thousand seven hundred and eighty *six*

THE Condition of this Obligation is such, That if
the above bounden *Robert Gray* Administrator
of all and singular the Goods, Chattels, and Credits of *John Gray*
deceased, do make, or cause to be made, a true and perfect Inventory of all
and singular the Goods, Chattels, and Credits of the said deceased, which
have or shall come to the Hands, Possession, or Knowledge of him the said
Robert Gray
or unto the Hands and Possession of any other Person or Per-
sons for him and the same so made, do exhibit, or cause to be exhibited,
into the Register's Office, in the County of Chester, at or before the
fifteenth Day of *October* next ensuing; and the same Goods, Chat-
tels and Credits, and all other the Goods, Chattels and Credits, of the said
deceased at the Time of his Death, which at any Time after shall
come to the Hands or Possession of the said *Robert Gray*
or into the Hands or
Possession of any other Person or Persons for him do well and truly ad-
minister according to Law. And further, do make, or cause to be made,
a true and just Account of his said Administration, at or before the
fifteenth Day of *August* *one thousand seven hundred & eighty seven*
And all the rest and residue of the said Goods, Chattels and Credits, which
shall be found remaining upon the said Administrators Account, (the same
being first examined and allowed of by the Orphans Court of the County
of Chester) shall deliver and pay unto such Person or Persons respectively,
as the said Orphans Court, by their Decree or Sentence, pursuant to the
true Intent and Meaning of the several Laws now in force in this Com-
monwealth, shall limit and appoint. And if it shall hereafter appear, that
any Last Will and Testament was made by the said deceased, and the Exe-
cutor or Executors therein named, do exhibit the same into the said Re-
gister's Office, making request to have it allowed and approved accord-
ingly: and if then the above bounden *Robert Gray*
being thereunto required, do render and deliver the said Letters of Admi-
nistration, (approbation of such Testament being first had and made in the
said Register's Office) then this Obligation to be void and of none effect,
or else to remain in full Force and Virtue.
